# SETUP

## General Mounting Guidelines

Do NOT place the VB-S on its front, back or top when in use.

Do NOT place any objects on top of the VB-S.

Avoid placing the VB-S near air conditioning vents, heaters or radiators, fans, or other sources of noise or vibrations.

To avoid wireless interference, keep other wireless equipment **0.3-0.9 m (1-3 ft)** away from the VB-S. Place the VB-S outside and away from metal cabinets, other audio/video components and direct heat sources.

Make sure there is an AC (mains) outlet nearby.

Mount the VB-S directly below (preferred) or above a display with the grille facing into the room. If you mount the VB-S above a display, ensure there is sufficient airflow from the heat vents of the display.

For best sound and microphone performance, do NOT place the VB-S in an enclosed cabinet or diagonally in a corner.

Make sure the seating area of all meeting participants fits within the camera's field of view (FOV). All meeting participants must be in the FOV in order for the autoframing feature to work properly (see **Enable/Disable Autoframing (Page 38)**).

The FOV of the VB-S camera is 115° horizontal, 81° vertical.

Make sure the meeting room can be well lit during a meeting.



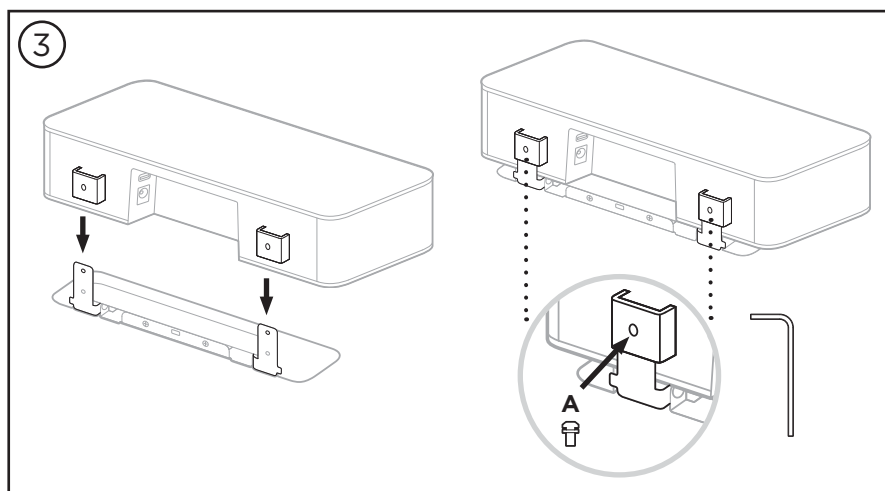
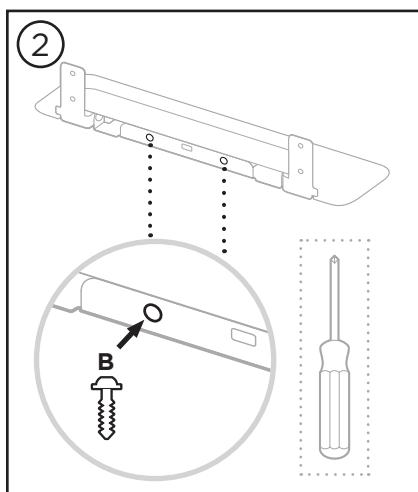
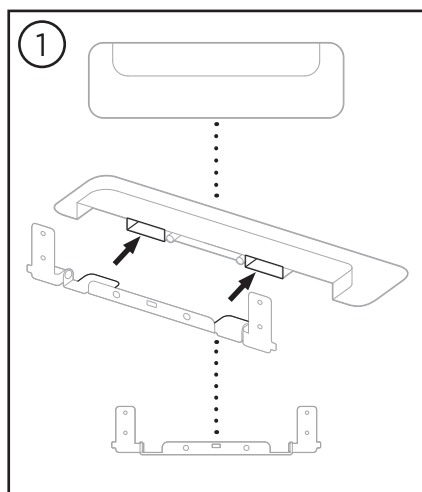
## Mount the VB-S on a Table, Shelf, or Credenza

For best performance, when setting up the VB-S on a table, shelf, credenza, etc., follow these recommendations:

See **General Mounting Guidelines (Page 14)** first.

Place the VB-S in its table stand on a stable and level surface.

Position the front of the VB-S so the supporting surface is not visible in the camera's image. Make sure the meeting room can be well lit during a meeting.



## Wall-mount the VB-S

For best performance, follow these recommendations when setting up the VB-S on a wall:

See **General Mounting Guidelines (Page 14)** first.

When determining where to attach the wall-mount bracket to the wall, make sure there is enough space around the bracket to fit the VB-S:

There must be at least **3.8 cm (1.5 in)** above the wall-mount bracket. This will allow you to “hang” the VB-S on it (Step 6) and to adjust the angle of the VB-S. It will also provide enough space to access the rear-panel connections on the VB-S.

There must be at least **11.4 cm (4.5 in)** below the wall-mount bracket. This will allow you to hang the VB-S vertically during installation to insert cables and to adjust the angle of the VB-S.

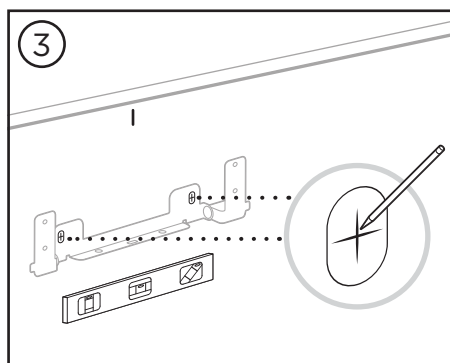
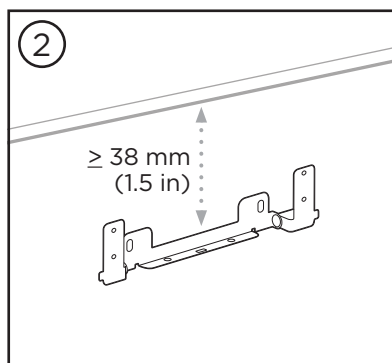
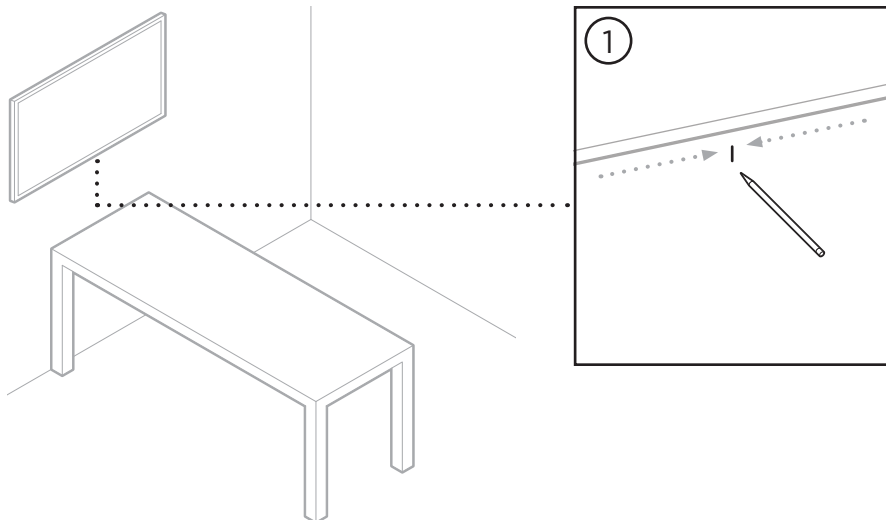
The space must be at least **31.8 cm (12.5 in)** wide with the wall-mount bracket in the center of it. This is necessary to accommodate the VB-S plus space to access the acoustic port on the sides of the VB-S (there should be **2.5 cm (1.0 in)** on each side).

Only use the included hardware to wall-mount this product.

**Note:** Some additional tools are required.

## Mount the VB-S on a Camera Stand or Tripod

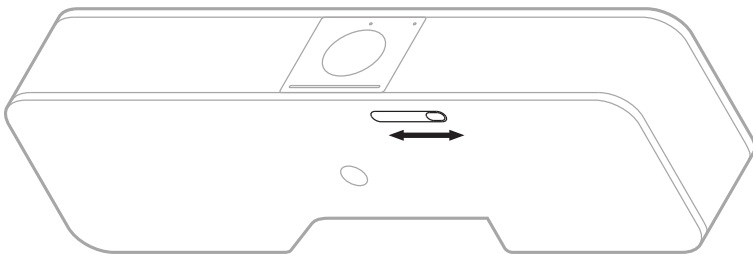


On the underside of the VB-S, there is a  $\frac{1}{4}''\text{-}20$  UNC-threaded insert with a depth of 9 mm (0.35 in).

As an alternative to tabletop-mounting or wall-mounting the VB-S, you can use this insert to attach the VB-S to a camera stand, tripod, or other mounting device.

If you use this insert, ensure the mounting device attached to it can support the weight of the VB-S without creating a tipping or falling hazard. Also, do not overtighten the screw in the insert, which could cause damage.

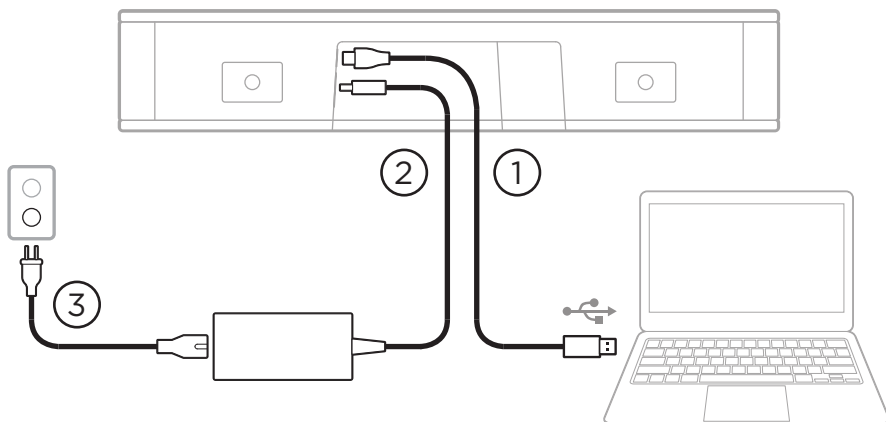
## Camera Privacy Cover



The camera privacy cover enables you to completely cover the camera's field of view without hiding the indicators or the light bar.

Slide the small switch on the underside of the VB-S (to the right of the camera) left or right to cover or uncover the camera.

## Cable Connections



1. Connect the included USB-C® cable to the **USB-C** port.

Leave the other end of this cable on the table, so the meeting host can easily connect or disconnect their computer each meeting.

**Note:** If a computer hosting a meeting has USB-C ports only, attach the included USB-A-to-C adapter to the computer end of the USB cable.

2. Connect the included power supply to the **Power** input.
3. Use the included power cable to connect the power supply to a power outlet. The VB-S will power on automatically when connected to a power source.

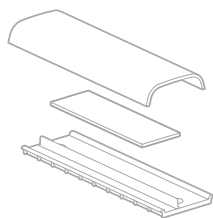

**Note:** If you also own Bose Professional Videobar VB1, do not use the USB cable included with the VB1 to connect the VB-S to a computer. (The VB1 USB cable is designed specifically for that model.)

## Cable Management

The included cable management cover can hold all permanent cabling in place against a wall.



Cable management plate,  
foam, and cover



Small flathead screw (2)

Small drywall anchor (2)

To install the cable management cover:

1. Place and hold the back of the cable cover (the piece with the screw holes) against desired location on wall.
2. Mark the center of the two screw holes on wall, and remove the back of the cable cover.
3. If that part of the wall has a stud behind it, drill two 2.4 mm ( $\frac{3}{32}$  in) holes into the wall.  
  
If that part of the wall has no stud behind it, drill two 5 mm ( $\frac{3}{16}$  in) holes into the wall.
4. If that part of the wall has no stud behind it, drive the two small drywall anchors (**G**) into the wall.
5. Align the back of the cable cover with the screw holes.
6. Drive the two small flat-head screws (**F**) into the back of the cable cover to secure it to the wall.
7. Gather the cables and place along the “guide” of the back of the cable cover (on the wall).
8. Remove the adhesive strip from the cable cover foam.
9. Firmly place the foam strip on the back of the cable cover, next to the gathered cables.
10. Place the front of the cable cover over gathered cables and foam so it adheres.

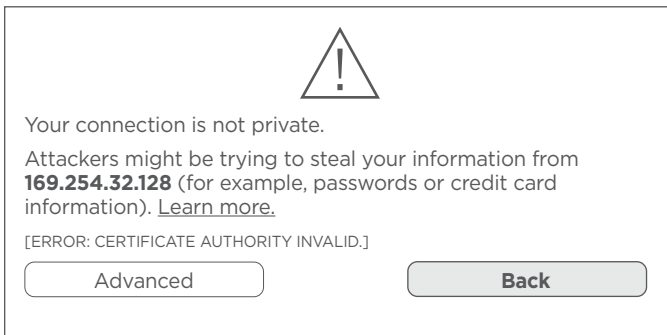

To access and use the browser-based Videobar Configuration WebUI to configure the VB-S over a network connection:

1. Connect your computer and the VB-S to the same network. (See the user guide in the Videobar Configuration app to learn how to learn how to do this.)
2. Enter the IP address of the VB-S into the address bar of a web browser on your computer, and press **Enter**. (You can determine the IP address of the VB-S using the Videobar Configuration app over USB or using the Videobar Administration app which automatically discovers VB-S devices on the network.) The Videobar Configuration WebUI will open.

**Note:** On some browsers, you may see a security warning like this:





This is normal and not a security risk. Click **Advanced**. (If you are ever unsure about performing an operation on your computer, in a web browser, etc., check with your IT/system administrator first.)

You may then receive a follow-up message:

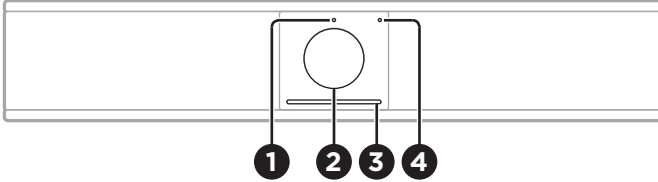

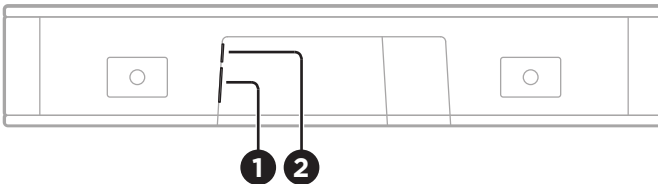

**Lit solid white:** The VB-S is connected to a *Bluetooth* mobile device for use of the Videobar Mobile or for calls and audio playback.

**Off:** No *Bluetooth* connectivity.

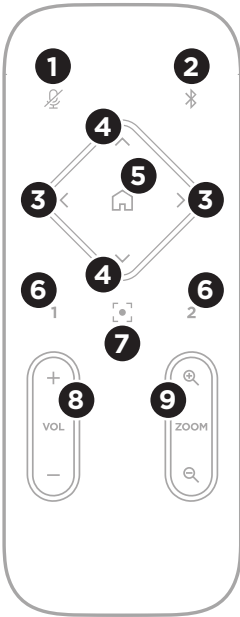
1. **Power:** Connect the included power supply.
2. **USB-C:** Connect this port to the computer hosting the meeting.

**Note:** If you also own Bose Professional Videobar VB1, do not use the USB cable included with the VB1 to connect the VB-S to a computer. (The VB1 USB cable is designed specifically for that model.)

## Remote Control

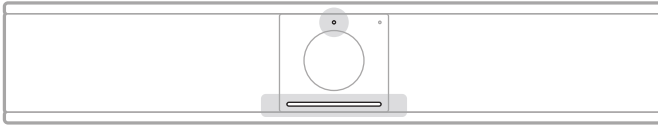
The Videobar VB-S includes an infrared remote control that enables you to adjust camera and volume settings, mute the microphones, and put the VB-S in *Bluetooth* pairing mode.

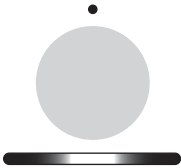
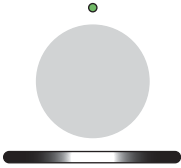
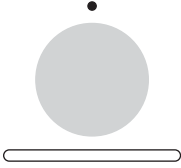
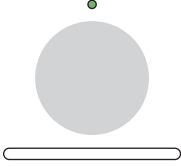
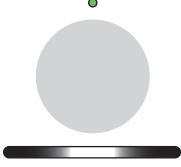


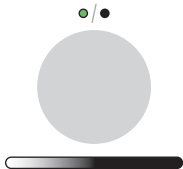
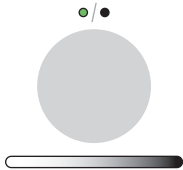
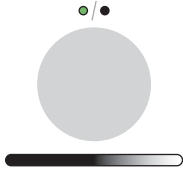
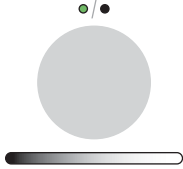
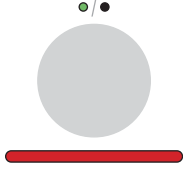
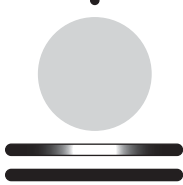
1. **Mute:** Mute/unmute the VB-S microphones.
2. **Bluetooth:** Press and hold for 3 seconds to enter pairing mode. If already paired to a device, press and hold to disconnect.
3. **Camera Pan:** Press to pan the camera left and right (< or >), or press and hold for continuous adjustment.
4. **Camera Tilt:** Press to tilt the camera up and down (▲ or ▼), or press and hold for continuous adjustment.
5. **Home Preset:** Return Pan, Tilt, and Zoom (PTZ) camera settings to the Home position. The Home position can be changed in the Videobar Configuration app.
6. **Presets 1 & 2:** Press to select Preset 1 or 2 for the camera. Press and hold to save the current Pan, Tilt, and Zoom (PTZ) camera settings as Preset 1 or 2.
7. **Autoframe:** Turn autoframing on/off. When on, the pan, tilt, and zoom (PTZ) camera settings will adjust automatically to include all participants in the field of view at all times.
8. **Volume:** Raise or lower volume (+ or -).
9. **Camera Zoom:** Increase or decrease (+ or -) the zoom ratio of the camera.

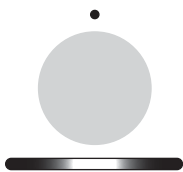
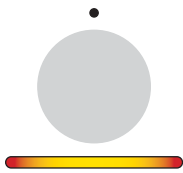
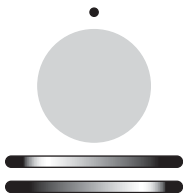

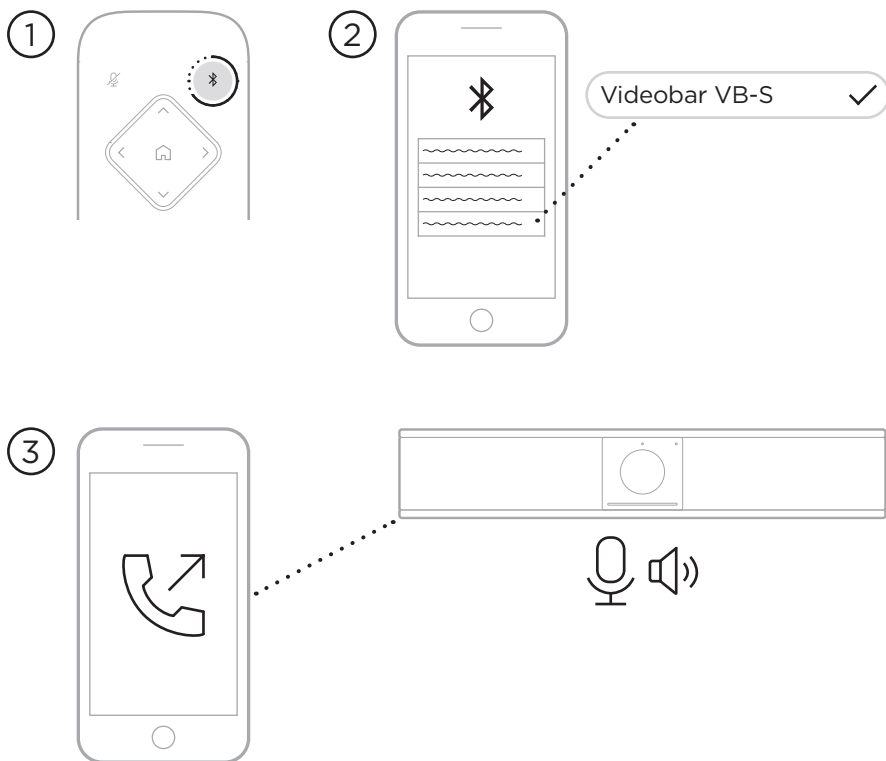
## Start a Meeting



To start a meeting using the VB-S:

1. Connect the included USB cable between the VB-S and your computer. Use the included USB-A-to-C adapter, if needed.
2. Start the meeting in your preferred meeting software.
3. In the device settings of your meeting software, select **Videobar VB-S** as the device for the microphone, speaker, and camera.

## Make a Call

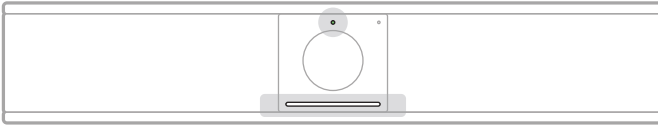


To make a call using the VB-S as a speakerphone:

1. Press and hold the **Bluetooth** button on the remote control for 3 seconds to put the VB-S into pairing mode.
2. On your mobile device, scan for available *Bluetooth* devices and select the VB-S.
3. Make a call from your mobile device. (On some mobile devices, you may need to select the VB-S once more when you use it for a call for the first time.)

The audio will be automatically routed from your mobile device to the VB-S speaker and microphones.

## Adjust the Camera



The status indicator above the camera and the light bar below the camera indicate the status of the VB-S. When the camera is on, the status indicator will also be on (whether or not there is an active meeting).

**Note:** All remote-control functions are also available in the software apps that enable you to configure the Videobar VB-S. See **Software Applications (Page 23)** for more information.

**Tip:** For quick and simple adjustments to the camera settings, we recommend using the Videobar Mobile app on your mobile device. See **Videobar Mobile App (Page 26)**.

## Reset the Camera



To return the camera to its default pan, tilt, and zoom settings, press the **Home** button on the remote control.

## Adjust the Pan and Tilt Angles



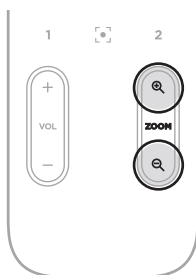
**Note:** You can adjust the pan and tilt angles only if the camera is not fully zoomed out.

To adjust the pan (left-right) angle of the camera, press one of the camera pan buttons (< or >) on the remote control.

To adjust the tilt (up-down) angle of the camera, press one of the camera tilt buttons (^ or v) on the remote control.

Press a button once to adjust the camera in increments, or press and hold it for continuous adjustment.

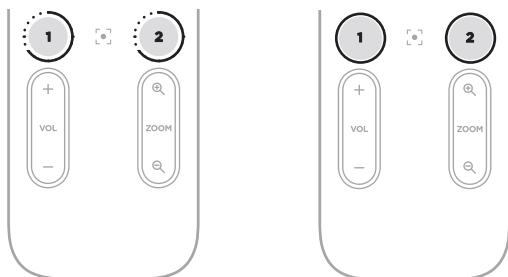
## Adjust the Zoom Ratio



To adjust the zoom ratio of the camera, press one of the **Zoom** buttons (+ or -) on the remote control.

Press a button once to adjust the camera in increments, or press and hold it for continuous adjustment.

## Save and Recall a Preset



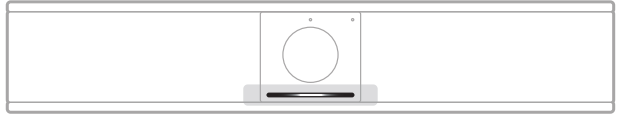
You can save the camera's pan, tilt, and zoom settings to a preset: Preset 1 or Preset 2. When you recall a saved preset, the camera will immediately return to the saved pan, tilt, and zoom settings.

To save a preset:

1. Adjust the pan, tilt, and zoom settings as desired.
2. Press and hold the desired preset button on the remote control (**Preset 1** or **Preset 2**) for 3 seconds. The camera settings will be saved to that preset.

To recall a saved preset, press the desired preset button on the remote control (**Preset 1** or **Preset 2**). The camera will immediately change the pan, tilt, and zoom settings to those saved to that preset.

## Enable/Disable Autoframing



To enable or disable the camera's autoframing feature, press the **Autoframe** button on the remote control.

When autoframing is enabled, the camera will automatically and continuously adjust the pan, tilt, and zoom settings to include all participants in the room in the field of view. A small section of lights in the center of the light bar will be lit solid white.

**Note:** Adjusting the pan, tilt, or zoom settings or selecting **Home**, **Preset 1**, or **Preset 2** will automatically disable autoframing.

When autoframing is disabled, adjust the camera's pan-tilt-zoom (PTZ) settings manually. The whole light bar will be lit solid white.

## Manage Audio Levels

The Videobar VB-S has three audio inputs: its microphones, USB audio, and *Bluetooth* audio.

The VB-S also has two audio outputs: its speaker and USB audio.

The real-time levels of all of these signals can be seen in the **Meters** tab of the Videobar Configuration app or WebUI.

## Local Audio Playback

Music or audio over the USB or *Bluetooth* inputs are played back through the VB-S speaker (the near end).

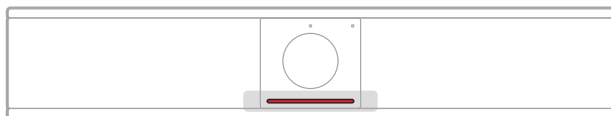
During meetings, this USB audio will not be sent to the other participants (the far end), but *Bluetooth* audio will be sent to the far end if the meeting audio and *Bluetooth* audio are "bridged." Bridging is enabled in the VB-S by default, but you can disable or reenale it by using the Videobar Configuration app or WebUI or the Videobar Administration app (see **Software Applications (Page 23)**).

## Meeting Audio

The VB-S microphone audio is sent to the other participants (the far end) via the USB output after the Acoustic Echo Cancellation (AEC) feature.

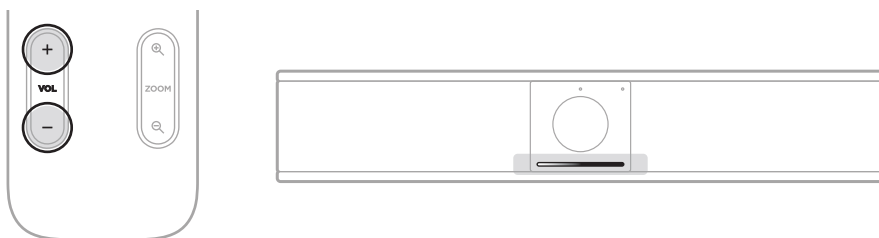
If local audio playback is sent over the USB input, it will play over the VB-S speaker, but the AEC feature will remove the music from the VB-S microphone audio pick-up before sending it to the far end.

If you wish to send local audio playback to the far end, share the audio playback app within your meeting software.



To mute or unmute the VB-S microphone, use the **Mute** button on the remote control. When the microphone is muted, all lights in the light bar will be lit solid red.

## Adjust Audio Levels



To adjust the volume of the VB-S speaker, use the **Volume +** or **-** buttons on the remote control, adjust the volume of the host computer, or adjust the volume of the *Bluetooth* audio. The light bar will indicate when the volume has been raised, lowered, or set to its highest or lowest level. See **Status (Page 29)** for more information.

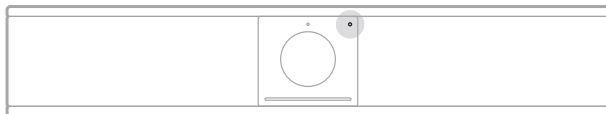
These three volume levels are always synchronized, so adjusting one of them adjusts the others as well.

**Note:** All remote-control functions are also available in the software apps that enable you to configure the Videobar VB-S. See **Software Applications (Page 23)** for more information.



## Manage *Bluetooth* Devices

The VB-S can be paired with one *Bluetooth* device at a time. For instance, it cannot be paired with one device using the Videobar Mobile app and another device for calls or audio playback.



The *Bluetooth* indicator on the front panel indicates the current status of VB-S *Bluetooth* connectivity:

**Slowly pulses blue:** The VB-S is available to pair to a *Bluetooth* mobile device.

**Lit solid white:** The VB-S is connected to a *Bluetooth* mobile device for use of the Videobar Mobile app or for calls and audio playback.

**Off:** No *Bluetooth* connectivity.

The VB-S will not automatically reconnect to a previously paired *Bluetooth* device. Once the *Bluetooth* connection is lost (due to distance, intentional disconnection, etc.), you will need to follow the steps to pair again.

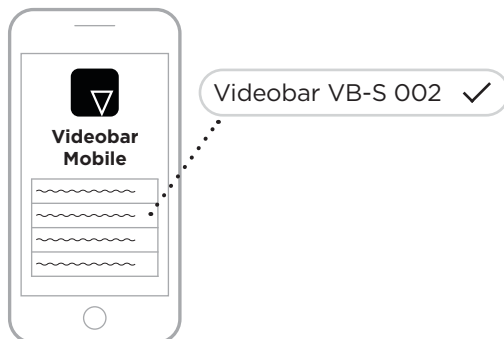
## Pair a *Bluetooth* Device with VB-S



To pair a *Bluetooth* device with the VB-S for calls or audio playback:

1. Press and hold the ***Bluetooth*** button on the remote control for 3 seconds to put the VB-S in its pairing mode. The *Bluetooth* indicator on the front panel of the VB-S will slowly pulse blue.
2. On your *Bluetooth* device, scan for other available *Bluetooth* devices and select the VB-S. The *Bluetooth* indicator on the front panel of the VB-S will light solid white when connected.

The Videobar Mobile app can pair your *Bluetooth* device with the VB-S using *Bluetooth* Low Energy (BLE). The app will automatically “discover” VB-S units nearby.



To pair a *Bluetooth* device with the VB-S using the Videobar Mobile app, open the app and select the desired VB-S. The *Bluetooth* indicator on the front panel of the VB-S will light solid white when connected. (See **Videobar Mobile App (Page 26)** for more information.)

## Disconnect a *Bluetooth* Device from the VB-S



To disconnect a *Bluetooth* device from the VB-S, do one of the following:

- Disable the *Bluetooth* connection on your mobile device.

- Press and hold the **Bluetooth** button on the remote control for 3 seconds.

- Move your *Bluetooth* device away from the VB-S until it is out of range of its *Bluetooth* signal (which can vary based on the transmission strength of your *Bluetooth* device as well as environmental factors like physical obstructions or other signal interference).

## Low-Power/Standby Modes

Some countries' energy regulations require products like the VB-S to enter a standby mode, a low-power state of operation that saves energy while the product is inactive. This low-power mode is enabled in the VB-S by default, but you can disable or reenable it by using the Videobar Configuration app or WebUI or the Videobar Administration app (see **Software Applications (Page 23)**).

**Note:** Disabling the low-power mode will cause the VB-S to consume more energy while it is inactive.

When the low-power mode is enabled:

If the VB-S is connected to a network, the VB-S will enter a networked standby mode after 18 minutes of inactivity.

If the VB-S is not connected to a network, its standby mode has two stages. The VB-S will enter an initial low-power state after 18 minutes of inactivity. After two more hours of inactivity, the VB-S will enter its lowest-power state. In both states, the light bar on the front of the VB-S will be off. To enter this non-networked standby mode, the VB-S must be disconnected from any USB device and its *Bluetooth* and Wi-Fi connectivity must be disabled.

When the low-power mode is disabled, the VB-S will not enter the standby mode or networked standby mode.

Certain actions or commands can prevent the VB-S from entering its standby mode or can return the VB-S to its normal operation by “waking” it from its standby mode or networked standby mode:

## CARE AND MAINTENANCE

### Clean the VB-S

The VB-S may require periodic cleaning.

Wipe the outside surfaces with a soft, dry cloth.

Do not allow moisture to get inside the grille or any cable/wire connections.

### Replacement Parts and Accessories

Replacement parts and accessories can be ordered through Bose Professional customer service. Visit **boseprofessional.com**.

### Limited Warranty

The Videobar VB-S is covered by a limited warranty. Visit our website at **boseprofessional.com/warranty** for details of the limited warranty.

### Serial Number Locations

The serial and model numbers are located on the rear panel of the product.

You can also view the serial number in the Videobar Configuration app or WebUI or in the Videobar Administration app (see **Software Applications (Page 23)**).

## Restore the Factory Default Settings

Restoring the factory default settings will do the following:

- Clear the list of *Bluetooth* devices paired to the VB-S.

- Clear the camera presets (Home, Preset 1, and Preset 2).

- Return all camera, microphone, and speaker settings to their default values. (Many of these settings are configured in the Videobar Configuration software or Videobar Administration software.)

- Reset the administrator password to **Bose123!**

**Note:** We recommend changing the password after resetting it.

To restore all settings of the VB-S to their factory defaults, press and hold the **Home** button and **Autoframe** button on the remote control simultaneously for 5 seconds.

A small section of lights in the center of the light bar will pulse white repeatedly. The lights will then move outward from the center until the whole light bar is lit solid white. The lights will then fade out. When this process is completed, the VB-S will restart with its factory default settings.

## Forgotten Password

If you have forgotten the password to access the Administrator configuration settings, you must restore the factory default settings to reset the password (see **Restore the Factory Default Settings (Page 45)**).

**Note:** We recommend changing the password after resetting it.

## Update the Software

You can use the Videobar Configuration app and Videobar Administration app to check for and install VB-S firmware updates. See **Software Applications (Page 23)** to learn how to download and access these software apps.

If you are using the Videobar Configuration WebUI to configure the VB-S, you may not be able to automatically check or update the firmware from the online server unless your computer is also connected to the internet.

If you cannot access firmware updates while using the WebUI, do one of the following instead:

- Use the Videobar Configuration app.

- Use the Videobar Administration app.

- Download the firmware file directly to your computer, and then use the Videobar Configuration WebUI to update the firmware as if it were a previous version.

# TROUBLESHOOTING

## Try these solutions first.

If you experience problems with the VB-S, try these solutions first:

Make sure the VB-S is connected to power.

Make sure any cables connected to the rear panel are securely connected. See **Cable Connections (Page 21)**.

Check the status indicators. See **Front Panel (Page 27)**.

Make sure your mobile device supports *Bluetooth* connections.

Check for available VB-S software updates. See **Update the Software (Page 45)**.

Move your *Bluetooth* device closer to the VB-S and away from any interference or obstructions.

Adjust the volume on the VB-S, computer, *Bluetooth* device, or any other audio sources. See **Manage Audio Levels (Page 39)**.

If you could not resolve your issue, see the table below to identify symptoms and solutions to common problems. If you are unable to resolve your issue, contact Bose Professional customer service. Visit **boseprofessional.com**.

Problem	What to Do
I hear music but my computer is not connected.	Check if the <i>Bluetooth</i> indicator is lit solid white. If so, someone's <i>Bluetooth</i> device may already be paired with the VB-S. Press and hold the <b>Bluetooth</b> button on the remote control for 3 seconds to disconnect it.
The sound is too quiet or not audible at all.	<p>The volume may be too low. Raise the volume using:</p> <ul style="list-style-type: none"> <li>the VB-S remote control</li> <li>your <i>Bluetooth</i> mobile device (if you are using one)</li> <li>your meeting software (speaker volume)</li> </ul> <p>If you still hear no sound, make sure <b>Videobar VB-S</b> is selected as the speaker in your meeting software.</p>

Problem	What to Do
The camera zooms in or out even when I am not manually adjusting it.	<p>The camera's autoframing feature may be enabled. Press the <b>Autoframe</b> button on the remote control to disable it.</p> <p>Some meeting software apps have built-in autoframing, which may be cropping the image or changing the camera zoom ratio. If possible, disable this feature in your meeting software.</p>
The camera moves around a lot when the autoframing feature is enabled.	<p>The camera's autoframing feature might not be set to the best mode for the meeting space. Use the Videobar Configuration app or Videobar Administration app (see <b>Software Applications (Page 23)</b>) to change the autoframing mode from <b>Individual</b> ("Follow Me") mode to <b>Group</b> ("Conferencing") mode or vice versa. Refer to the user guide in the app for more information.</p>

The indicator above the camera lens is lit solid green.	<p>This is normal. This indicates the VB-S camera is on. (If the light bar is lit white, then there is an active meeting.
